We issued one newsletter to all members with copies to the Central Library and Library of Scotland.

Our main source of income continues to be from subscriptions, donations and sales of cards, books etc, pertaining to the murals. This year we received a number of donations to assist with setting up our web site and installing a credit card donation box.

Membership of the Charity is open to anyone. At 31 August 2024 the Charity had 121 individual and 3 Patron members
